- b) Apron (shin length) with neck & waist ties, which is available in one size only; Model PA30L0.
- c) Sleeves (50 cm length) with elastics at cuffs & upper arm, which is available in one size only; Model PS32LA.
- d) Boot cover (knee length) with a slip retardant sole stitched to the fabric (not a liquid-tight connection), which is available in one size only (maximum shoe size that can be worn is 45 (UK size 11); Model POBA.
